Gretchen Wolf Swartz refereed girls high school basketball from 1981 to 1995, advocating and displaying sportsmanship. Following her untimely death to leukemia in 1997, fellow officials discussed a memorial fund to promote sportsmanship. In December of 1999 the Gretchen Wolf Swartz Scholarship Fund, Inc. gained 501(c)(3) acceptance. Following a fund-raising campaign, the first scholarships were awarded in 2000-2001.

# **Rewarding Excellence**

Each year, the York/Adams Chapter of PIAA Basketball officials, selects a girls' and boys' basketball team from YAIAA member schools. Observing grades 7-12, the officials look for examples of good sportsmanship from players, coaches and fans. The two winning programs receive a trophy for their outstanding sportsmanship.
